The PCF is the framework for social work practice and learning in England and performs the following functions: sets out nine common domains of capability for social workers; promotes and underpins social work for all social workers across all specialisms and roles; supports social workers to meet requirements of the professional regulator;

It sets capability statements of what is to be expected for all stages of a social worker's career from entry into training to the most advanced level of a social work practitioner. It is a generic framework that applies to all social workers in all settings.
